
What about LMT vs what ISDCF uses for language codes? Bottom line, let's keep the current language codes that is specific for Digital Cinema. LMT is a SMPTE process (RDD) and it may be considered "boiling the ocean" for all uses of language codes including consumer products (OTT/Broadcast). One problem is that within a studio there are conflicts and they need to resolve this issue internally.

If Sperling and Gardiner can connect to fix the files, we can get back running.



ISDCF Immersive Audio

SMPTE-RDD starting for Profile 1 - sponsored by ISDCF and EDCF - paperwork submitted to SMPTE. We asked for the document to be made available NOT behind a paywall.

There is a need to inform exhibition that a DCP that is labeled "IAB" it will play on "Atmos" rendering solutions. We need to let exhibitors know that even if it doesn't have "Atmos" it can play. We need to do our best to avoid confusion when new releases are being distributed.

We will seriously address this when new movies are again being released.

Has anyone implemented new features in IAB devices that others have implemented that need to be part of an IAB profile 2? No manufacturer indicated they have implemented new features.

OMB testing for new protocols. 430-17 / 430-14? No indication of timing. No need to schedule a plugfest at this time.

SMPTE-DCP

Update to SMPTE standards - B2.1 documentation - RDD-52. Waiting on IEEE to publish. Any moment now...

ISDCF sent a liaison letter to SMPTE asking that RDD-52 and other SMPTE documents be placed outside of the SMPTE firewall/paywall.

When do we want to change the ISDCF documents that are included in the RDD-52 (i.e. ISDCF Document 4 - audio channel assignments). BUT if the RDD-52 costs money and we want this information to be openly available. (Letter below.)

Dear Bruce,

After publishing is complete on SMPTE RDD 52 D-Cinema Packaging - SMPTE DCP Bv2.1 Application Profile, ISDCF kindly requests on behalf of the D-Cinema industry that it be available free-of-charge to the public and not behind a firewall or paywall of any type.

ISDCF has been working with the industry for over fourteen years. We hold plug-fests in support of documents for industry specifications and initiate many recommended practices, some of which have become SMPTE standards through SMPTE TC 21DC and TC25CSS.

In fact, RDD 52 was inspired by the work that ISDCF has been doing for many years. Many of the sections of RDD 52 are taken directly from ISDCF Technical Documents that have been freely available on our website < https://www.isdcf.com/site/technical-docs/>.

For example, both ISDCF Document 4 - Audio Channel Assignments and Document 13 - Sign Language Video Encoding for Digital Cinema are both fully incorporated into RDD-52. Other parts of RDD 52 come from testing and multiple discussions held at our meetings, as well as previously noted Plugfests.

ISDCF strongly desires a single, central location to provide mastering guidance for the D-Cinema industry and wishes to point the industry to the contents of RDD 52 without friction. It is to our joint benefit that new entrants to our industry find and use this guidance. Thank you for your consideration of this request.

While this request is specifically for RDD 52, more generally ISDCF would like to see a number of SMPTE Digital Cinema standards more easily accessible. This might mean freely available or a fixed cost for access to a specific subset of standards. The current access is too challenging to be widely available and the standards not being used or adhered to by some authoring facilities.

Nothing back from SMPTE so far...

Suggestion was to hold off on starting the RDD for IAB until we get assurance it will be in the free/clear.

August restart?

Carston Kurz gave us a tour of a German Theater (sold out) to see the set up of a working theater.

Take ways:

- Every person must leave contact information for contact tracing (on paper, will be shredded after about 4 weeks many people don't remember their phone numbers!) Paper is still the best way. Some pre-fill the forms before they arrive at the theater.
- Pool noodles are used as separation measurements to maintain social distancing.
- 400 seat theater has been reduced to 130 seats. (Absolute max is 300, but social distancing drives it down to 130.)
- Patrons must wear masks when not seated. (Can take off mask when seated.)
- Cinemas are getting some support from the government (however, they have not qualified as of now).

ISDCF is probably not the right place to share ideas for health methodology for the re-opening of theaters. ISDCF could facilitate creation/distribution of PSA (public service announcements) for safe operation.
