### Forum

The current installation of the ISDCF Forum is not working. There is interest in

getting it up and running again and the suggestion is to find a new location to host it.

We could have a "closed" section and an "open" section in the forum. The ISDCF discussion list is the "closed" section (with a low bar to join).

The Forum could be the resting place and summary of discussions that happen internally in the discussion list. In the past it was not active.

We suggested that James/Sperling come up with a proposal - where to host, how to manage, how (and if) past posts are migrated to the new forum. This outline would be presented to the group (either at the next meeting or on the discussion list) to help determine if we should move forward. The general feeling is that we should move forward and see if it gains traction.

### **ISDCF Immersive Audio**

SMPTE-RDD starting for Profile 1 - sponsored by ISDCF and EDCF - paperwork submitted to SMPTE. We have not heard back... Jerry will follow up with SMPTE.

We did discuss how the IAB document will be maintained after publishing by SMPTE. Our philosophy is that ISDCF will manage the master IAB document and continue to post on the ISDCF website and point to the SMPTE document (when available). The two documents will remain in sync and if ISDCF addresses new changes they would be submitted to the SMPTE-RDD document.

Has anyone implemented new features in IAB devices that others have implemented that need to be part of an IAB profile 2? Nope. Will ask again next meeting.

OMB testing for new protocols. 430-17 / 430-14 Not yet finished in SMPTE.

Maybe a plugfest for subtitling (micro positioning) 428-7 standard plugfest. ISDCF may be asked to conduct some testing. Nothing planned at this time.

#### SMPTE-DCP

Update to SMPTE standards - B2.1 documentation - RDD-52. Published and available FOR FREE to the end of the year. SMPTE RDD52 [https://ieeexplore.ieee.org/document/9161348].

ISDCF will maintain and update duplicate information on ISDCF technical updates and submit changes to SMPTE for RDD-52 (i.e. the If changes do happen in SMPTE it will be rippled into ISDCF documents - that are always free to the public.)

### The Restart

Things seem to be going very well. A few issues (less than expected), but nothing out of the ordinary. Some re-boots fail, but "normal" issues.

The message of "Turn your gear on EARLY and test with encrypted content ASAP before reopening" has make it to exhibitors. It probably doesn't hurt to leave the recommendations on the website.

# Naming Convention / Language Codes

We had a lively discussion on the usability for Appendix #1ab - Language Codes. It seems to be meeting the needs of the machine readable aspects, but falls short in sorting by name or including the legacy naming convention name of languages. Bottom line: A sub-group will meet to determine user needs and how best to address. The goal is to have one (and only one) active database for language codes (and only one for studios and only one for facilities).

We need a better way to sort the table. It was decided that "random" is not the best way to be sorted/displayed. :)

We need to add a new sort field based on DCNC legacy name.

We should archive the old spreadsheet as part of an archive (in .pdf) for future.

We want to remove XX and MOS from the official language code list (but define in the info-text). XX only applies to CTT (content title text) and NOT to include in the machine readable CTP content.

We also want to remove "NULL" from the studio codes / facility codes.

The SMPTE/LMT project is going on independently and we will coordinate if and when they are ready for our input.
