No great pressure or need for a social hour on a monthly schedule, but maybe on a once a quarter meeting would be good.

Immersive Audio Naming

A release was made using the "IAB" in the naming of the movie and there was confusion for many exhibitors. There was no "backup" 5.1 or 7.1 version that was keyed to the ATMOS theater so the operator was lost - no ATMOS and no other version that would play - ignoring the fact that the IAB version would play.

[There is a second issue of releasing an IAB package with a 7.1 base, but it doesn't seem that this is the issue identified here. The recommendation has been to not include a 5.1/7.1 fall-back base as part of the IAB package, but some studios are playing it "safe" and include those tracks. The identified issue is an operator not trying to play the IAB version since it didn't say ATMOS.]

Some options:

- 1. We get the word out to all theaters that have either ATMOS or a compatible IAB system that IAB is the new name for immersive sound? [Use studio communication channel.]
- 2. Send a fall back **version** for theaters as they learn about "IAB" naming. (Sending both an IAB version and a 7.1 version.)
- 3. Include ATMOS-IAB in the naming convention until people learn that IAB=ATMOS?
- 4. Just deal with it! Make the name change to IAB and the education will be the help desk (Deluxe/Pixel Logic/etc) to fix the problem. The folks that don't know about IAB will learn really fast!

NATO has issued memos informing operators about the ATMOS = IAB, but these are not being communicated to the on-site operators.

Studios bookers may have the best means to inform operators to get the word out that IAB=ATMOS to all operators that read the files name.

Chairman's Comment: My conclusion is that we just make the change, send out content labeled "IAB" and let individual exhibitor scramble and call the help desk to be informed and play the IAB version. The number of sites that are ATMOS/ Other are very small and it should only take one call to solve the problem for now and in the future. Keep trying to get the word out, but it's time to rip the bandage off.

SMPTE Trailers

===

The industry would like to shift to all SMPTE-DCP trailers. This would reduce the need to send multiple hard drives - some with SMPTE-DCP and some with Interop-DCP trailers.

Many of the independent distributors still create Interop-DCP trailers. There is desire to shift on January 1, 2022. We may need to have a "date certain." Not sure who could make that call. Probably a call by studios to give instructions to their vendors.

Side Note: The biggest issue with folks creating a "bad" SMPTE-DCP is the use of the wrong audio configuration. To create a valid SMPTE-DCP the audio MUST be mastered in configuration 4 (WTF).

DCP Validation

Do we need a freely available DCP validator? It has worked in IMF. Open source code. Phase 1 would be a CPL validator. Later to test the MXF. There is an on-line open source tool "Clairmeta" tool at <u>https://github.com/Ymagis/ClairMeta</u>.

Another side-screen presentation system is being deployed/tested. ICE has been installed at LA Live. It uses side-car delivery of content.
